She spearheads mitigation strategies, exclusion requests, and CAPE submissions that have resulted in millions of dollars in duty refunds.

She also covers a wide range of customs issues including valuation, classification, duty preference programs such as USMCA, reconciliation, duty drawback, protests, and voluntary disclosures to US Customs and Border Protection (CBP).
